- ❖ 22 On Sale Intoxicating liquor licenses
- ❖ 20 On Sale 3.2 Non-Intoxicating Malt Liquor licenses
- ❖ 8 Off Sale 3.2 Non-Intoxicating Malt Liquor licenses
- ❖ 4 Club liquor licenses
- ❖ 15 Wine only liquor licenses
- ❖ 6 Brewery Liquor Licenses
