Last week our Department initiated a child pornography investigation when we discovered a 12 year old Roseville girl had been coerced into sending nude photographs of herself to men she met through social media. In return, several adult men sent her explicit and pornographic photographs and videos and tried to coerce her to participate in additional sexual activities. Luckily, the girl's mother stumbled across this horrible situation when the girl left her account open. The Roseville Police Department is working closely with the Internet Crimes Against Children Task Force and we will do everything we can to hold these men accountable for their actions. Unfortunately, these types of **predators are all too common** in our society.

This is a great opportunity to have ongoing discussions with your children about their online activities. Children can be very naïve and fall prey to criminals bent on stealing their innocence. *I am taking my own advice with my kids this week*.

Call us; we want to be bugged in the middle of the night

Recently a very nice resident of Roseville called us on a Wednesday morning after she heard suspicious noises in her neighborhood closer to midnight the previous night. She provided great detail to the daytime officer on what she heard over nine hours earlier. In this case, two males were overheard stating, "How am I supposed to carry all this stuff". Problem is, we love to get this information at the time it is occurring in order to intercept the origins of the noise.

Firecrackers and anything that shoots into the air and explodes is illegal in Minnesota.

If your kids want to experience neighborhood fireworks stop by your local fireworks stand in Minnesota to pick them up- this way you are not stepping into territory you may not wish to go and it's safer if there is an accident.
