While the Parks and Recreation System Master Plan has not identified this parcel specifically, the City Council has identified the SE area of the Community as a priority to work on in 2016 and this concept may fit into that plan. There is a deadline approaching to submit a grant application therefore creating a need to discuss this soon.

If this property is acquired it would be designated as park land and then be the responsibility of the City to maintain, operate and capital improve.

3. APPROVAL OF MINUTES – November 5, 2015 MEETING

November 5th minutes approved unanimously.

4. EMERALD ASH BORER (EAB) UPDATE

Anita Twaroski, Roseville Forestry Coordinator, introduced herself to Commission members and viewing public.

Brokke and Twaroski walked the Commission through the Emerald Ash presentation providing historical context and City of Roseville action & involvement. Most of Roseville is identified in the infestation zone.

- Commissioners inquired into the potential impact of EAB, staff responded that EAB will eventually impact the entire U.S.

Goals of the Roseville EAB Program:

- Monitor & evaluate suspect trees
- Remove & replace positive EAB trees
- Treat significant trees
- Plant a more diverse & resilient forest
- Identify & utilize available resources
 - o Currently Roseville is working with a \$125,000 DNR grant to address EAB needs. This grant also involves \$125,000 in City funds as a matching contribution.

EAB is a difficult pest to identify. Roseville is probably about midway into its EAB infestation. Roseville has 2146 Public Ash trees (this number does not include Ash trees located in local wooded areas).

- Commissioner Becker-Finn recommended educating the public on recognizing Ash trees and signs of EAB.

Twaroski presented the current tree distribution plan. Ten species have been identified for inclusion in the plan. The tree planting map has been developed using the constellation system. Each constellation has a specific planting map that provides a varied and diverse forest. The end goal with the city-wide tree distribution plan is to have no ash trees in the City.

- Commissioner Doneen suggested creating an annual plan/goal for removing/replacing trees.

Commissioner comments suggested the Council is not addressing the need to plan for the full EAB crisis.

- It would cost Roseville \$1.6M to remove & replace the community forest affected by EAB.
- Commission Chair Stoner commented that the Commission needs to work harder to keep the Council informed & it is important to keep this issue on their radar.

58 **5. REVIEW CITY COUNCIL JOINT MEETING**

59 Commissioners shared their thoughts & reactions to the meeting.

- 60 • Holt is concerned about the process for Park Dedication funds. Using the funds for current
61 capital needs will lead to the fund being depleted.
 - 62 o Stoner added that Park Dedication funds cannot be anticipated and counted on.
 - 63 o Becker-Finn suggested there is a lack of real understanding of how park dedication
64 works & operates and the related statutory constraints.
 - 65 o Holt suggested it may be smart for Commissioners to contact Council members
66 directly and provide information from an informed group.
- 67 • Commissioners were encouraged by the Councils reaction to the Cedarholm Golf Course
68 Clubhouse discussion.
 - 69 o Commissioners believed the Council was asking them to;
 - 70 ▪ Compile public comment
 - 71 ▪ Strategize funding & design
 - 72 ▪ Suggest a process
 - 73 ▪ Explore potential partnerships
 - 74 o There was consensus that the direction should be to rebuild to a similar size as the
75 current clubhouse.
 - 76 o Doneen suggested engaging the community early in the process to create a skeletal
77 vision.
 - 78 ▪ Commissioners agreed the initial process should pattern previous Parks and
79 Recreation task forces and the master plan process.
 - 80 o Staff will provide a draft vision for the Golf Course Clubhouse Taskforce at the
81 January meeting.

88 fair benefits the Harriet Alexander Nature Center.
- 89 • FORParks hosts the annual Holiday Gala on December 11 at the Skating Center. Local American
90 Idol alumni Paris Bennett is performing.

91 Brokke added:

- 92 • Staff are hosting a Natural Resources Community Meeting on Saturday, December 12.
- 93 • The next monthly Natural Resource Park Project is on Saturday, December 19 at Oasis Park.
- 94 • Upper Villa Park (adjacent to the B-Dale Club) has been the site of a HUGE storm water project
95 this fall. Work at this site will improve local wetlands and Lake McCarrons and minimize erosion.
- 96 • Staff are finalizing many Renewal Program projects, while none are officially closed out, many
97 are very close.

Lonnie, could you add this proposal to the Parks and Recreation Commission agenda for January 5? This is coming at a fast pace due to the grant deadline of February 18. We are hoping to get some conceptual approval from the Parks & Recreation Commission before we meet with the City Council on February 8.

Attached to this email includes a profile of the community project, a map of the area, the grant information, and the 2016 Policy Priority Plan that was adopted by the City Council on December 7. Page three of the priority plan discusses the focus on Karen in Southeast Roseville including exploring recreational opportunities.

The U.S. Bank grant we are seeking is through their 'Places to Play' Initiative that awards funding to communities who demonstrate a need for playground/recreation space in low to moderate income neighborhoods.

Over the last year the Karen Interagency Work Group, and recreation programming sub-group, have identified the need for direct play space at the Brittany/Marian Apartments. It is estimated that 200+ Karen youth live in the rental buildings that surround the vacant parcel at 1716 Marion St (see map attached).

Partnerships between the City of Roseville, the Roseville Police Foundation, Roseville Area Schools, International Institute of Minnesota, and Karen Organization of Minnesota have come together to support a proposal that would request a grant from U.S. Bank for funding for playground equipment at this site. HealthEast Foundation is also interested in exploring a partnership. The closest park for the Karen youth is Tamarak Park, which has limited accessibility and requires a significant amount of foot traffic through single family residential.

We hope the Parks & Recreation Commission will offer a recommendation, or conceptual approval, on how to proceed. We understand that the 1716 Marion St parcel is not a part of the Park's Master Plan, but we don't want to lose an opportunity to bring much needed playground and recreation space to our large refugee population in Southeast Roseville.

A presentation with greater detail is tentatively scheduled for the February 8 City Council meeting. Please let me know if you have any questions in the interim, and please include this email in the materials to the Parks & Recreation Commission.

Community Project Profile - 1716 Marion St., Roseville, MN 5511-6716

Partners: Roseville Police Foundation, Roseville Area Schools, Karen Organization of Minnesota, International Institute of Minnesota, and Roseville Parks & Recreation Commission, *referred to as “the Partners”*

Objective: To provide access to appropriate play space and playground equipment for the 200+ youth that reside in the apartment buildings surrounding 1716 Marion St., Roseville, MN 55113.

Background: The City of Roseville prides on the reputation of stellar recreation programming and park amenities for Roseville residents. The Partners listed above have determined that a large amount of Roseville youth, primarily Karen refugees, do not have the access to playground equipment and play space in the dense rental areas of southeast Roseville. Through various interagency groups, the Partners have identified an opportunity at 1716 Marion St. Roseville, MN 55113 for such use.

The vacant lot at 1716 Marion St. abuts the apartment buildings and would provide direct play space for the tenants in the Brittany/Marion apartments. A map of the lot and surrounding area is included for your review.

Recently the City of Roseville became aware of an opportunity through US Bank’s ‘Places to Play Program’ for grant dollars for recreation use. The grant dollars would be used to purchase the playground equipment. A copy of the US Bank Request for Proposal (RFP) is attached.

Approvals Necessary for the Completion of the Project Include:

- 1) The Partners would like to seek advice, or a recommendation from the Park & Recreation Commission meeting on **January 5** before moving forward with the grant. US Bank would like conditional approvals to accompany the grant materials in an effort to gauge project feasibility.
- 2) Community Development Block Grant (CDBG) funds will be requested from Ramsey County in 2016, and will be used to satisfy the Match Funding requirement identified in the RFP.

2015 REQUEST FOR PROPOSALS (RFP)

Overview

The U.S. Bank Places to Play Program is a collaboration between U.S. Bank and the Minnesota Vikings that provides community-based non-profit organizations and schools with grants to improve the quality, safety, and accessibility of local play spaces in low- to moderate-income communities in Minnesota. Recreation and play spaces serve as tremendous community assets because they offer opportunities for recreation and relaxation that improve the local quality of life, especially for young people. U.S. Bank Places to Play is intended not only to respond to the immediate shortage of safe recreation and play spaces, but also to build an infrastructure through resident involvement to sustain these recreational spaces for community use.

U.S. Bank believes in putting people first - our employees, our customers and our communities. U.S. Bank Places to Play is a great example of that commitment. U.S. Bank and the Minnesota Vikings are collaborating to invest \$1 million over three years to give youth, families and communities across the State of Minnesota access to safe places to play and engage in recreational activity. This grant-making initiative will focus on parks, playgrounds, indoor/outdoor athletic facilities and repairs to existing trails.

In order to be eligible for a grant under the Program, projects must be sponsored by community-based non-profit organizations registered as exempt from Federal Income Tax under Internal Revenue Service Code Section 501(c)(3) or by schools in low- to moderate-income communities in Minnesota.

Strong preference will be given to those proposals that (1) seek to upgrade existing facilities that are in poor condition or otherwise underutilized; (2) demonstrate active use of the spaces; (3) **attract matching funding that exceeds the minimum required match of 1:1**; (4) involve local partnerships with non-profit community partners (e.g., Parks and Recreation departments, YMCA branches, etc.) to promote youth safety and community programming; and (5) provide for continuing maintenance and safety.

Proposals are due February 18, 2016 at 12:00 p.m. CST

Please read the complete RFP before requesting a proposal submission link.

Availability of Funding

Matching grants of \$25,000 to \$50,000 will be available to provide general recreation space support. Community-based non-profit organizations and schools in low- to moderate-income communities may submit requests for capital projects associated with actual recreation and play spaces. This includes the installation or refurbishment of parks, playgrounds, indoor/outdoor recreation facilities and repairs to existing trails.

Organizational Eligibility Criteria

To be eligible for the U.S. Bank Places to Play Program, organizations applying for grant funds must meet **all** of the criteria listed below:

- Be a community-based non-profit organization or school serving a neighborhood consisting primarily of low- to moderate-income families and individuals. Please note:

- o Schools must demonstrate the ability of the community to also utilize the recreation space;
 - o Universities and college campuses are not eligible to apply for funding from the U.S. Bank Places to Play Program and will not be considered.
- Have at least one full-time staff person (all-volunteer organizations will not be considered);
- Be in existence for at least three years;
- Have a proven track record in real estate development and/or parks programming;
- Have 501(c)(3) tax-exempt status/school status

Funding Restrictions

The U.S. Bank Places to Play Program will not provide funding for:

- organizations that are not tax-exempt under Internal Revenue Code section 501(c)(3), except public schools.
- fraternal organizations, merchant associations, chamber memberships or programs, or 501(c)(4) or (6) organizations.
- section 509(a)(3) supporting organizations.
- fundraising events or sponsorships.
- "pass through" organizations or private foundations.
- organizations outside the State of Minnesota.
- programs operated by religious organizations for religious purposes.
- political organizations or organizations designed primarily to lobby.
- individuals.
- travel and related expenses.
- endowment campaigns.
- deficit reduction.
- organizations receiving primary funding from United Way.
- organizations whose practices are not in keeping with the company's equal opportunity policy.

Selection Criteria

Organizations and their projects will be selected for funding based upon the following criteria:

1. **Feasibility of the proposed project.** The project budget must be based upon realistic costs, preferably written contractor's estimates.
2. **Project readiness.** Sources of funding for the entire budget should be identified. Plans for renovation should take into account the schedule of recreation activities over the course of the year. A project timeline should be specified in the proposal. Projects should have plans for completion by November 1, 2017.
3. **Impact upon neighborhood and support from the community.** Only proposals that locate projects in low- to moderate-income communities in the State of Minnesota will be considered. The proposal should clearly state how the improvements would benefit the community. It also must clearly detail how many youth and adults will make use of the recreation space. Moreover, the proposal must include a projected increase in the number of people that will use the facility as a result of the U.S. Bank Places to Play improvements. Support letters from other

neighborhood and partner organizations and joint use agreements (where applicable) must be included as well as contact information for the youth organizations and school programs scheduled to use the facilities (if applicable).

4. **Match funding.** The U.S. Bank Places to Play Program requires a minimum local match of one dollar for every dollar granted (1:1). For example, if the proposal requests \$25,000 from the Program, it must demonstrate sources and commitments for at least \$25,000 in local funds. ***Match funding at a higher ratio will strengthen the proposal.***
5. **Security of future maintenance and safety.** Proposals must have written commitments of maintenance funding for a minimum of three years and a detailed three-year maintenance plan in order to demonstrate that the applicant will maintain the space despite projected wear and tear and potential overuse of the facility. As a reminder, U.S. Bank Places to Play funds may not be used for maintenance, as all grant funds must be used for capital expenditures.
6. **Capacity of organization and its partners to carry out project.** The applicant organization must demonstrate, through its current management team and previous experience, the ability to manage a project of this size and nature.

Other Terms & Definitions:

1. Capital improvements refer to the physical development of the recreation site and its surrounding amenities.
2. Public agencies (other than public schools) may not apply for grants from the U.S. Bank Places to Play Program. However, community-based non-profit organizations with 501(c)(3) designation, schools meeting all other organizational criteria, and private schools with 501(c)(3) designation may apply to make improvements on recreation spaces owned and managed by public sector entities (e.g. City, Parks and Recreation Departments, etc.). In those cases, the applicant must show evidence that (1) the public entity supports the proposal; (2) the public entity authorizes the applicant to carry out the proposed capital improvements (this authorization must take into account relevant labor/union regulations and liability issues); (3) the public entity demonstrates its financial commitment to maintenance; and (4) the facility is open to and used by the community for organized and other events through joint use agreements.

The Roseville City Code, Title 4, Chapter 411 has been created to help manage wildlife in the City.

AN ORDINANCE CREATING

TITLE 4, CHAPTER 411

**AN ORDINANCE RELATING TO THE MANAGEMENT OF WILDLIFE
IN THE CITY**

THE CITY OF ROSEVILLE ORDAINS:

SECTION 1: Title 1, Chapter 411 of the Roseville City Code is created to read as follows:

411.01: PURPOSE

It is the purpose of this Chapter to manage wildlife within the city and eliminate intentional feeding of wild animals for the following reasons:

- (a) Management of wildlife in urban areas is important to the health of residents and the animals.
- (b) Population management of wildlife is necessary to ensure a stable balance of resources and the reduction in nuisances for residents.
- (c) Intentional feeding causes unwanted concentrations of wild animals. ~~which can destroy garden crops and landscaping in areas of the city.~~
- (d) Intentional feeding results in an increased potential of public safety problems including car/animal crashes and the spreading of diseases.

411.02: DEFINITIONS

Wild Animal. Any animal that is not normally domesticated in the state, including but not limited to raccoons, turkeys, coyotes, deer, feral cats, foxes, ~~and~~ skunks, and waterfowl ~~ducks, geese, swans, herons, and egrets.~~

411.03: FEEDING OF WILD ANIMALS PROHIBITED

A. Except as hereinafter provided no person shall intentionally feed wild animals within the City.

B. Intentional feeding is defined as distributing one gallon or more within in one 24-hour period of grain, vegetables, fruits, nuts, hay, or a salt lick on the ground or at a location less than 5 feet above the ground or at any other location or in any other manner that regularly attracts wild animals.

C. The provisions of Section 411.03 shall not apply to the following:

- 1. Persons maintaining incidental living food sources such as fruit trees and other live vegetation
- 2. Persons feeding common small backyard birds using self-enclosed feeding devices or containers at least 5 feet above the ground.
- 3. Persons that cannot physically place materials 5 feet or higher from the ground as long as they comply with the other standards contained in Chapter 411.03(B).

3. Employees or agents of the City, County, State, the Federal government or veterinarians who in the course of their official duties have wild animals in their custody or under their management.

4. Persons caring for animals at the Roseville Wildlife Rehabilitation Center

5. Persons bringing wildlife into Roseville for educational purposes.

D. Violation of this ordinance provision will be subject to an administrative fine of \$100 for the first violation, \$200 for a second violation, and \$300 for each subsequent violation within a 24-month period. This section does not prohibit, prevent, or bar any other applicable remedies available at law for any conduct described in Section 411.03 including, but not limited to, nuisance abatement, civil injunction or criminal prosecution.

E. The Community Development Department is authorized to implement and enforce the provisions of 411.03. The Community Development Director shall promulgate rules, regulations, and/or policies consistent with all provisions herein.

F. Any person or persons against whom an administrative fine is imposed under Section 411.05 may appeal such administrative penalty pursuant to Chapter 102 of City Code.

411.04: DEER MANAGEMENT PLAN

A. The City shall develop and maintain a deer management program to manage the number of deer that may be adequately supported by suitable habitat within the City of Roseville. At a minimum, the deer management plan shall contain the following:

14. Provision of education to residents on the best management practices for coexisting with the deer population.

24. A bi-annual deer population count, as weather permits, using methodology endorsed or utilized by Ramsey County.

32. Determination of the amount of suitable deer habitat utilizing Minnesota Department of Natural Resources information and resources.

43. Tracking of the location of vehicle/deer accidents.

~~4. Provision of education to residents on the best management practices for coexisting with the deer population.~~

5. Annual reports to the City Council on the deer management program, including information about other deer hunts conducted within Ramsey County.

B. Notwithstanding other provisions of this Code, for purposes of managing the deer population in accordance with the adopted deer management program, deer hunts may from time to time be approved by the City Council, including the timing, location, method, and safety precautions, among other provisions, for such hunts.

411.05 SEVERABILITY

If any provision of this ordinance is found to be invalid for any reason by a court of competent jurisdiction, the validity of the remaining provisions shall not be affected.

SECTION 2: Title I, Chapter 503.10 of the Roseville City Code is hereby amended:

503.10 USE OF BOW AND ARROW

As used in this chapter, the term “bow and arrow” is defined as a bowed shaft of material such

as metal, wood or plastic, the ends of which are pulled into a bow formation by a string, cord, wire or any other type of material and used for the purpose of propelling an arrow by means of the power developed in pulling the string against the tension of the bow and further provided that the arrow used is pointed or is equipped with a pointed head of metal, plastic or other material capable of penetrating an object when propelled by the bow.

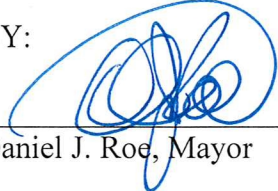
It is unlawful for any person to shoot a bow and arrow except: in a school program, on school grounds and supervised by a member of its faculty, a community class, a City Council authorized deer hunt pursuant to City Code Section 411.04, or on a bow and arrow range specifically authorized by the Chief of Police.

SECTION 3 : Effective date. This ordinance shall take effect upon its passage and publication.

4 **Deer Population Management Program and Policy**

5 **Purpose of Policy:**

6 Based on the City of Roseville's desire to balance the need for urban services with the
7 protection and management of our natural surroundings, the city hereby authorizes its deer
8 management program. The program is intended to maintain deer as an asset to the
9 community; prevent starvation and disease from overpopulation of deer; reduce the number
10 of motor vehicle accidents involving deer; and preserve and protect the land of property
11 owners;

12
13 **Scope**

14 City staff will administer a program of deer management within the parameters established
15 by this policy.

16
17 **Deer Population Count**

18 Bi-annually, an estimate of the deer population will be made using methodology endorsed by
19 the Minnesota Department of Natural Resources (DNR) and conducted by Ramsey County.
20 This information will also be shared with the DNR.

21
22 **Suitable Deer Habitat**

23 The amount of suitable deer habitat within Roseville will be determined by staff and updated
24 periodically based on development trends. Suitable habitat within Roseville includes city-
25 owned open space, private open space, wetlands (excluding water bodies), flood plains, and
26 any other undeveloped land. Minnesota DNR wildlife specialists establish an upper limit on
27 the number of deer that can be supported per square mile of suitable habitat.

28
29 **Removal of Deer**

30 The city may from time to time conduct a hunt in order to remove a portion of the deer within
31 Roseville. The City Council may order a hunt at their discretion after reviewing the most
32 recent deer population counts and amount of suitable deer habitat within Roseville. ~~Deer may
33 be removed through the use of an archery hunt.~~

34
35 The city must comply with DNR regulations regarding the removal of deer. This includes
36 receiving any applicable permits and removing deer during periods authorized by the DNR.
37 Removal methods must be approved by the DNR and must ensure the highest degree of
38 safety to residents.

39
40 **Vehicle/Deer Accidents**

41 Staff will review the locations of vehicle/deer accidents and take reasonable steps to improve
42 the safety of these areas when possible and feasible.

43
44

45 **Educating Residents**

46 The city will provide education to residents on the best management practices for coexisting
47 with the deer population. Other community education efforts will be undertaken to inform
48 residents about the deer management program.

49
50 **Annual Report to City Council**

51 Annually, city staff will provide the city council with a report on the status of the deer
52 management program, including information about other deer hunts conducted within
53 Ramsey County.
