On January 9, 2017, the City Council approved a design contract with Architects Hagen, Christensen & McILwain (HCM) for the clubhouse replacement project.

At your February 7, 2017 meeting, Tim McIlwain, Project Manager & Dan Lawrence, Project Architect of HCM were available to discuss and seek feedback on goals for the site, building & operations, along with site analysis & design opportunities that were gleaned from the Advisory Team Report.

On February 23, 2017 a community review and input meeting was held with 17 people attending. The agenda and handout/presentation for that meeting are included in your packet. They include initial concept bubble/component drawings to better understand program functions, sizes, and costs. The purpose of the meeting was to review process progress, gather further input, and confirm community direction.

Tim McILwain & Dan Lawrence will be at your meeting to discuss work to date that involves design options, form development & simple modeling for your input. They will also talk more about aspects of the maintenance operation at the site and how it might fit into the preferred option and what the considerations are for a phased approach.

We will look for your insight and input as we continue to sort through processes, designs and options with the community and the City Council. Topics that need to be worked out soon include, but are not limited to, the Historical Society consideration, final project budget, enterprise fund status and a phased approach.

This topic will be a regular agenda item each month in order to keep the full Commission updated, allow for continued community input, and to gather advice.

2. ROLL CALL/PUBLIC COMMENT

No public comment.

3. APPROVAL OF MINUTES – January 3, 2016 MEETING

Commissioner Bole requested to amend the attendance record from the January 3, 2017 meeting, as he was present. Commissioner Warzecha noted that the staff report had an omitted line.

Commission Recommendation:

Commissioner Diedrick moved to approve minutes as amended, Commissioner Bole seconded. Motion passed unanimously.

4. CEDARHOLM GOLF COURSE CLUBHOUSE REPLACEMENT PROJECT

Brokke introduced representatives from Hagan, Christensen & McIlwain (HCM). The City of Roseville previously utilized HCM to develop the concept plans for the new park buildings during the renewal program. Brokke reiterated that community and Commissioner input is highly encouraged during the Cedarholm design process.

Tim McIlwain and Dan Lawrence with HCM introduced themselves to the Commission. After reviewing the Cedarholm Advisory Team Final Report HCM has created a site diagram, which consists of general opportunities and goals for the Cedarholm Design Project. The site diagram is the first step to developing space programs, square footage numbers and concept plans.

McIlwain presented the Site, Building and Operational Goals listed on the HCM Site Opportunities Study dated February 1, 2017:

Site Goals

- Provide safer and better circulation in the parking area for cars and deliveries
- Expand and improve parking
- Improve public visibility of the facility through building location and signage
- Improve the entry sequence to the building
- Provide a larger entry staging area for golfers
- Maximize the use of the site buildable area
- Improve the configuration and flow of the Clubhouse, putting green and 1st tee
- Building siting/location to enhance views of the course

Building Goals

- Create a facility that supports golf operations but is multi-purpose and flexible for other uses such as:
 - Rentals for family, social or business events
 - Community Gathering Space
 - Presentations and events
 - The critical operational and functional goal is to provide golf space to the golfers. However, it is also important to ensure that a flexible space is created.
- Consider additional building "tenants" such as the Historical Society

- Estimated square footage requirements for the Historical Society is 1,300 square feet. Improve staff visibility and supervision of the parking area and 1st tee from the building
- Improve the views and connections to the site
- Improve the efficiency and relationship of the service functions (kitchen and retail spaces) for staff
- Gathering Space to be able to support 80-100 at tables to support golf tournaments & medium sized rentals
- Kitchen facility to support the facility golfers and rentals in the Gathering Space
 - McIlwain stated that there was a need to determine the use of the kitchen. He suggested that unique food offerings could potentially draw in non-golfers who are looking for a dining option.
 - Commission Chair Newby questioned if there is room at Cedarholm to support a unique restaurant venue. McIlwain stated that there is potential space for a restaurant utilizing the gathering space area. Commissioner O'Brien offered that a restaurant would inhibit the use of the building as a rental facility. Commissioner Warzecha noted the limited parking
- Develop a strong inside-outside relationship with decks and patios

- Improve the Maintenance Facility

Operational Goals

- Improve staff efficiency for golf check in and food service
- Improve food and beverage offerings
- Integrate retail into the entry rather than an enclosed shop space
- Relocate cart storage to reduce staff time and congestion at the Maintenance Building

Commissioner Heikkila offered the suggestion of adding bike parking on site to compliment the limited parking options. Parking is at a premium currently and opportunities to expand will be explored by HCM.

McIlwain explained that the next step is to create a Master Plan that would include space goals and cost per square foot. The Master Plan would include the maintenance operations – even if those plans were completed as a future project.

Commissioner O'Brien requested additional details on what was discussed during the Cedarholm Advisory Committee in regards to the potential for a restaurant. In response, Commissioner Stoner relayed that the restaurant was one of the top five issues that came up during the Cedarholm Advisory Team meetings. Commissioner Stoner also commented that he has concerns regarding the parking if a "destination restaurant" is added. However, he does believe that looking at the option of a restaurant could answer many of the multi-use topics that were discussed during the Cedarholm Advisory Committee meetings.

Public Comment

Dave Holt, the facilitator of the Cedarholm Golf Course Clubhouse Replacement Advisory Team, relayed that the overall group recommendation was for the Clubhouse to provide good quality food for the golfers, tournaments and catering events. As space and parking at Cedarholm is at a premium compared to other "destination restaurants" the main focus of Cedarhom should be as a Golf Clubhouse.

Commissioner O'Brien noted that a restaurant would be a completely different philosophical direction from what was recommended by the Cedarholm Advisory Team.

Commissioner Stoner questioned the different size needs based on a "nice restaurant for golfers" vs. a "destination restaurant". McIlwain responded that the two kitchen sizes would be very similar. He stated that you need to look at maximum building potential - to ensure the space is utilized 12 months out of the year.

Further discussion of the Cedarholm Golf Course Clubhouse Replacement Project will be at the Thursday, February 23, 2017 Community Meeting. The meeting will be held at the Autumn Grove Park Building from 6:30-8:30 p.m.

5. YOUTH OUTREACH PROGRAM REVIEW

Roseville Parks and Recreation Program Supervisor Lauren Deal relayed her 10 years of experience with the City Roseville. Recent and upcoming events that Deal supervises include the following:

- Daddy Daughter Sweetheart Dance This year's dance was enjoyed by over 50 couples!
- Kids Ice Fishing Contest
- Arts at the OVAL

- Dance Classes and Recital
- Discover Your Parks (DYP)
- Puppet Wagon

- Music Ensemble Preschool Music Classes
- Youth Fitness Boot Camps
- Youth Afterschool Activities (Art, Science, Games, etc.)
- Youth Summer Activities (Sports, Theater, Leadership, Field Trips, Art, etc.)

Dates and additional details for the programs listed above can be found in the Roseville Parks and Recreation activity brochure.

Deal also introduced the new "Rec Connect" program that she created with Recreation Program Supervisor Lake Johnson to target the Karen population in Roseville. The program will be available for kids ages 5-15, at Tamarack Park, with a drop-in format for registration.

Johnson reviewed the "Rec Connect" Program Planning Timeline that was utilized to create the program. Johnson and Deal met with other communities and cultural liaisons to develop the program. Once the program layout is established there is potential to bring this type of drop-in programming to other parks in the Roseville Community.

Deal presented the seasonal "Rec Connect" Summer Coordinator job opening posting. The interview process for this position has not yet begun. The job will be posted on the City website through March 1st. A desired qualification for the potential candidate would be an English-Karen bilingual speaker.

Brokke explained that this program was discussed with the City Council and that the now city-owned 1716 Marion Street property could also be utilized for the "Rec Connect" program.

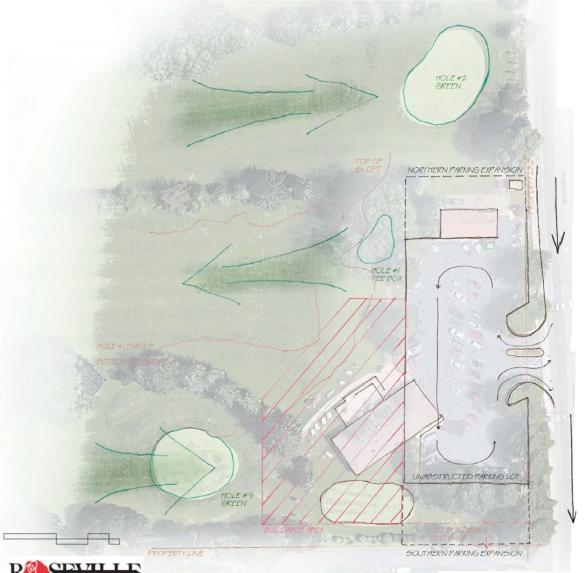

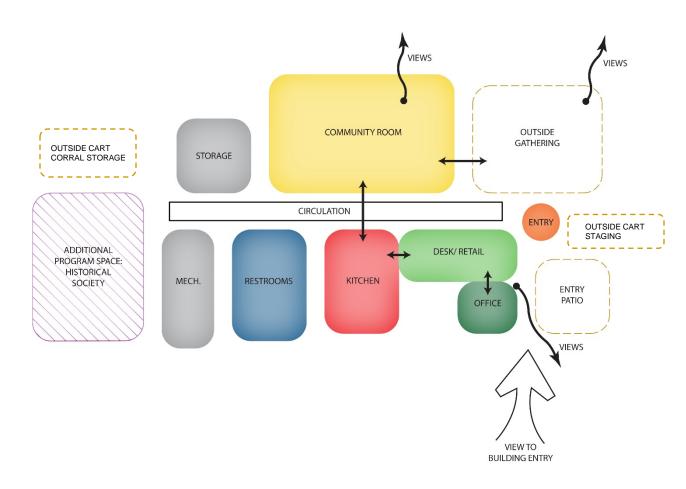

Cedarholm Clubhouse Renewal - Functional Plan Diagram

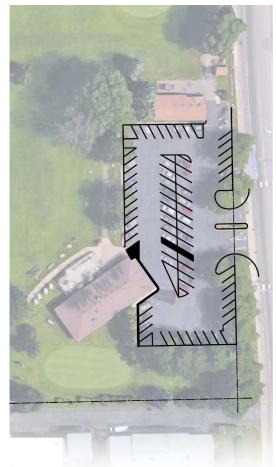

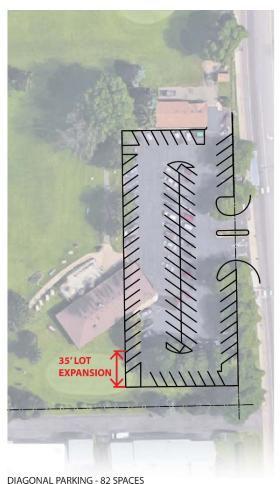

Cedarholm Clubhouse Renewal – Parking Plan Option Diagrams

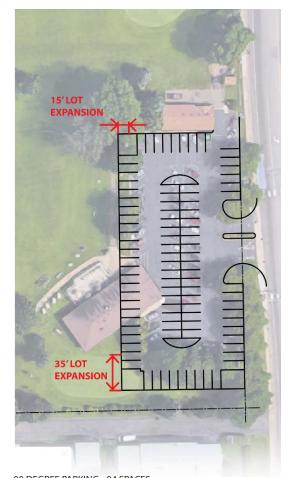


EXISTING PARKING - 68 SPACES

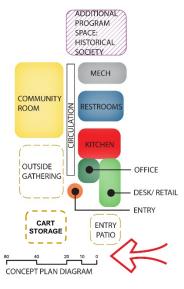

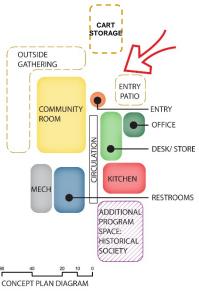


Concept Design Idea – Option A

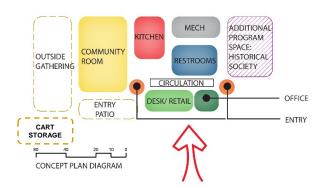

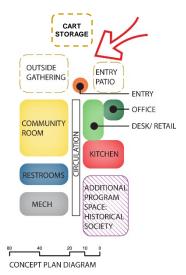
Concept Design Idea – Option C

- 1. Completed 22nd year as Nationally Accredited Agency
- 2. Replaced 3 replacement playgrounds, utilizing community builds involving 120 volunteers Mapleveiw Park, Upper Villa Park and Central Park Lexington
- 3. Initiated a Natural Resources Program Volunteer Stewardship effort that Hosted 12 Volunteer-supported Natural Resource Restoration projects (3rd Saturday of the Month)
- 4. Finalized a deer management program with the goal to monitor and control Parks and Recreation Commission effort

In 2013, a meeting was held that you may have participated in but the project had been placed on hold at that time.

We are now ready to begin the playground design process and conversation again this winter/spring with a playground design process. The actual installation of the playground will occur through a community playground build during the 2017 construction season.

We have scheduled three meetings to plan the playground replacement. At the first meeting, staff and consultants will gather your initial playground ideas. You will be asked to help us better understand what type of playground equipment would best fit in the park. Using input from this meeting our consultants will develop multiple concept plans that will be shared with you at the second meeting, this will give the consultants an idea on what you like and don't like about each proposal. These comments will be used to create the preferred concept that will be presented at the third meeting. The meeting dates are as follows:

New Finds

- EAB infested trees were discovered in Maple Grove (December) and Lake City (January).
- MDA presented EAB information to Maple Grove public works, parks and administration staff on January 12.
 After the presentation MDA and Maple Grove staff did a visual survey of the trees within a half mile of the original infested trees. More than a dozen trees showed woodpecker damage symptoms in the original neighborhood.
- MDA is scheduled to present EAB information and visual survey Lake City February 9. Jennifer will be scheduling presentations and/or visual surveys with known EAB infested cities in late March/early April.

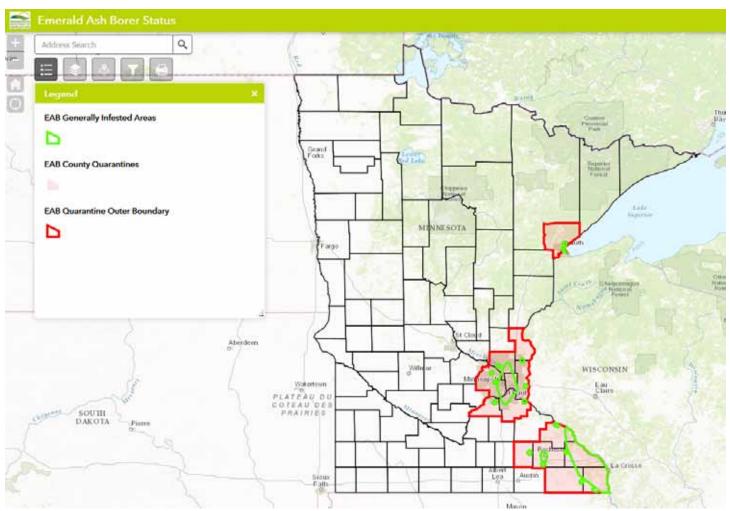


Figure 1. Statewide status of EAB

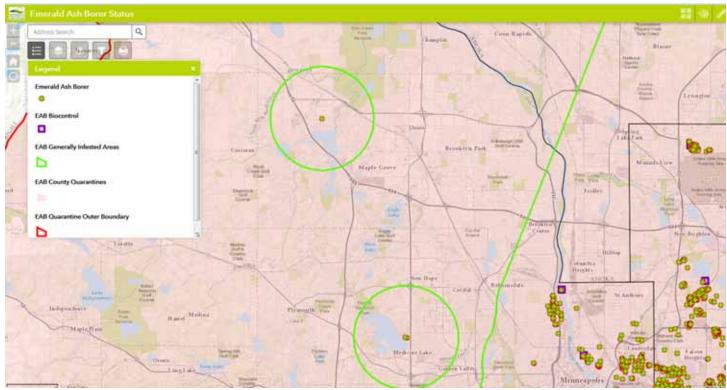


Figure 2. EAB in Maple Grove.

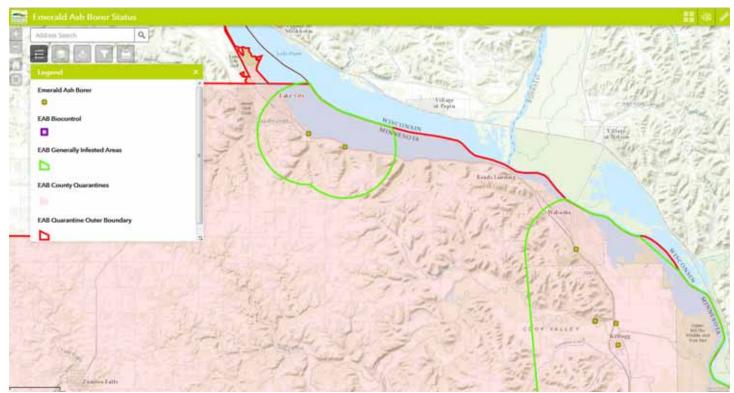


Figure 3. EAB in Lake City.

REGULATORY

NOTICE: <u>No</u> Regulated Articles are legally allowed to move outside of a quarantine (untreated <u>or treated</u>), unless they are accompanied by a certificate or limited permit. Certificates and limited permits are only available when a compliance agreement is signed between the Minnesota Department of Agriculture and the firm interested in moving the regulated article.



- Dodge County has been added to the formal EAB quarantine. Comments received were addressed and Commissioner Frederickson signed the formal Quarantine on November 2.
- On November 30, 2016 the public comment period closed for the proposed EAB quarantine for the southeastern portion of St. Louis County. Four comments were received. After a review by MDA, an expansion into the northeastern part of Carlton County was proposed. An additional 30 day comment period was opened for the proposed expansion and closed on January 15, 2017. Additional comments were received and as a result the quarantine boundaries are still under review.
- Seven (7) cooperative compliance agreements were renewed. Five (5) intrastate compliance agreement were renewed. Two (2) new intrastate compliance agreements were issued.
- Two (2) routine compliance inspections were conducted to ensure new equipment met the emerald ash borer treatment size requirements of 1" by 1" in two dimensions.

BIOLOGICAL CONTROL

• The MDA and DNR partnered to test yellow pan trapping methods for parasitoid recovery over the summer of 2016. A protocol and pan traps were provided by USDA AHPIS. Yellow plastic bowls were attached to the stems of living ash trees using shelving brackets. The bowls were filled with clear propylene glycol to trap insects that were attracted to the yellow color. Samples were collected from the traps twice a week from 06/03/16 to 09/09/16. Sampling involved pouring the propylene glycol through a filter and then bagging and freezing contents. Pans were then filled with new propylene glycol. A total of 870 samples were collected, frozen then examined in October and November. Samples were screened for suspected parasitoids which were sent to USDA APHIS for identification. This method resulted in 5 *Tetrastichus planipennisi* and 9 *Atanycolus simplex* cresson (a native parasitoid of EAB). The recovery of *T. planipennisi* is the first in the Twin Cities.



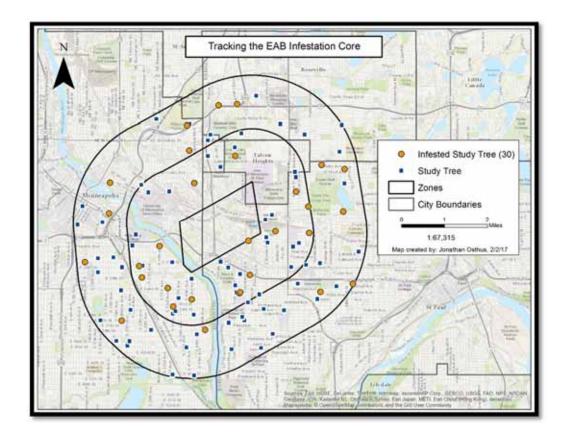
Figure 4. Parasitized EAB egg recovered from Ft. Snelling S.P.

• The MDA continues to collect and process bark samples from EAB biocontrol release sites with the goal of recovering the egg parasitoid, *Oobius agrili*. One parasitized EAB egg was recovered from a sample taken at Ft. Snelling State Park on 11/2/2016. This marks the second time in two years that *O. agrili* has been recovered from the park indicating the parasitoid wasp is established at the site.

RESEARCH

"Tracking the EAB Infestation Core" study is nearly complete with only 7 trees remaining to be sampled one last time. Of the 109 study trees, 30 have been found to be infested so far. Once sampling is complete, data will be analyzed at the U of M with final conclusions available in August. Results will be included in the final report to LCCMR for the project Biosurveillance and Biocontrol of EAB. Results from all 6 years of the study can be viewed at



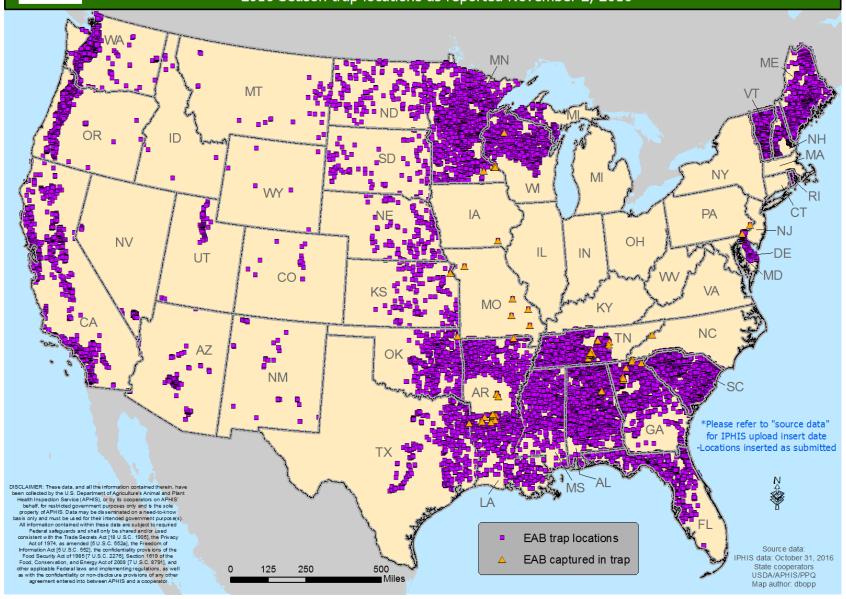


- The University of Minnesota (Sam Fahrner, Brian Aukema, Rob Venette) worked with the MDA to analyze the impact of tree removal by St Paul and Minneapolis on EAB population growth during 2009-2014 and is in the process of publishing a paper on the analysis. A key finding was that there were more EAB in trees with woodpecking than without. The management regime removed about 60% of the trees and reduced the beetle population by about 60%. The analysis suggested that about the same impact could have been made on the EAB population with about 30% of the trees removed if only woodpecked trees had been removed.
- The U of M and MDA have also been working on a study evaluating the effectiveness of monitoring in terms of informing management decisions. The results have been promising and indicate that any of the monitoring techniques tested (visual, trap, branch sampling) can identify EAB infestations before substantial impact to the overall canopy of the site.

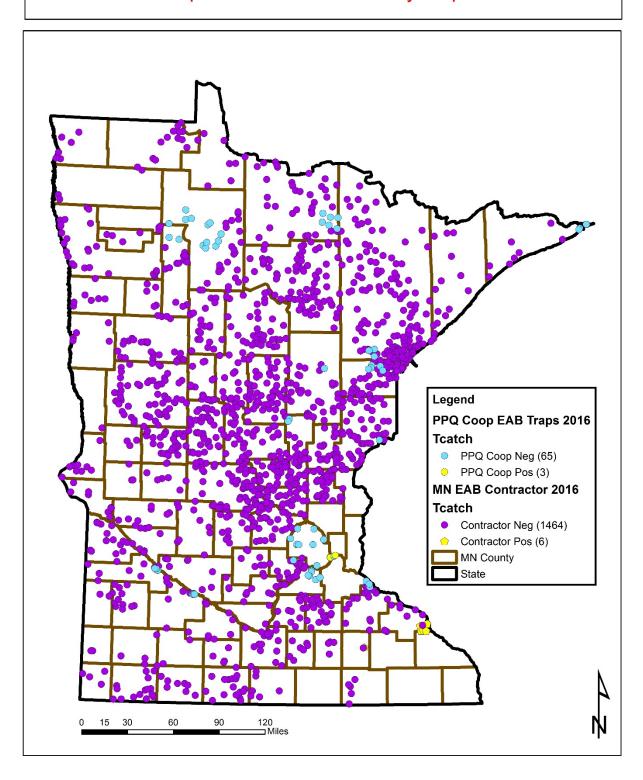


Cooperative Emerald Ash Borer Project

2016 Season trap locations as reported November 2, 2016*

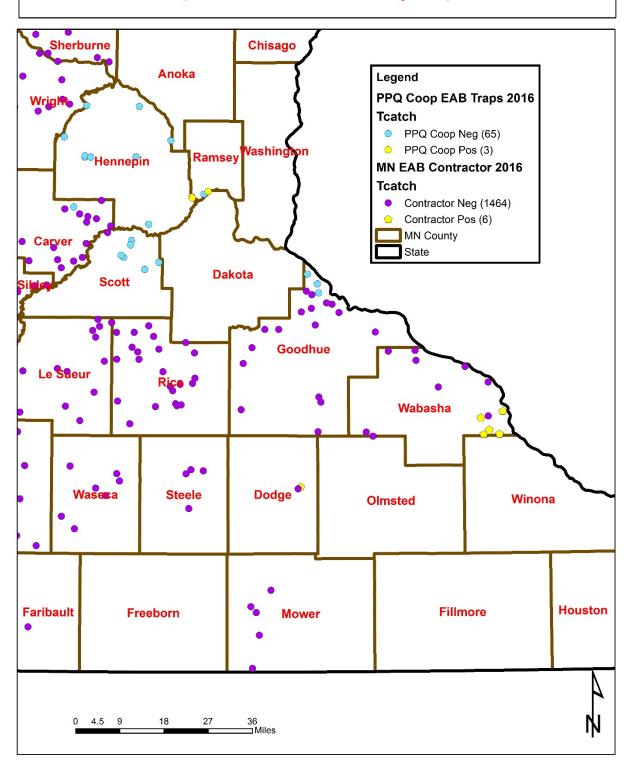


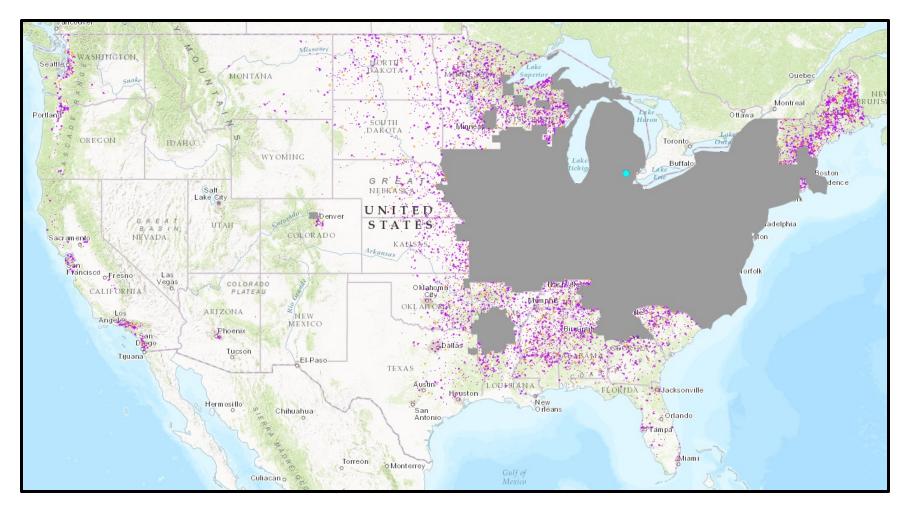
PPQ Coop/Contractor EAB Survey Traps -- 2016



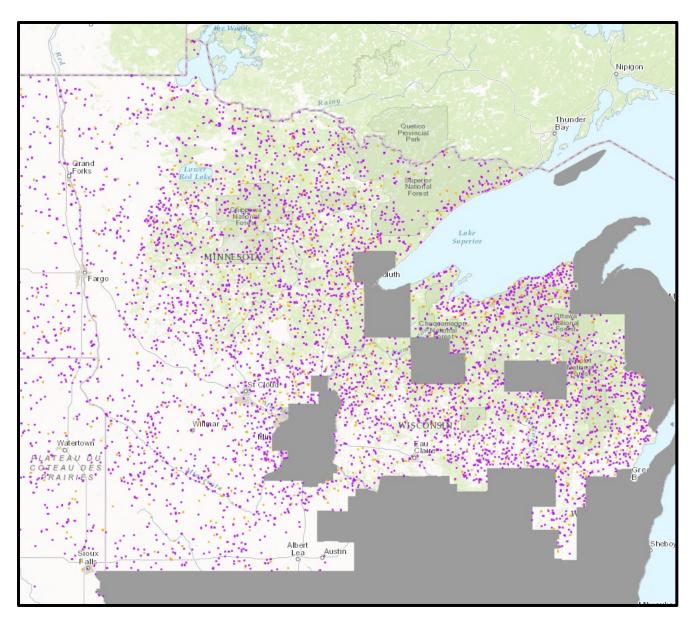
2016 Minnesota Contractor Set 1470 Traps

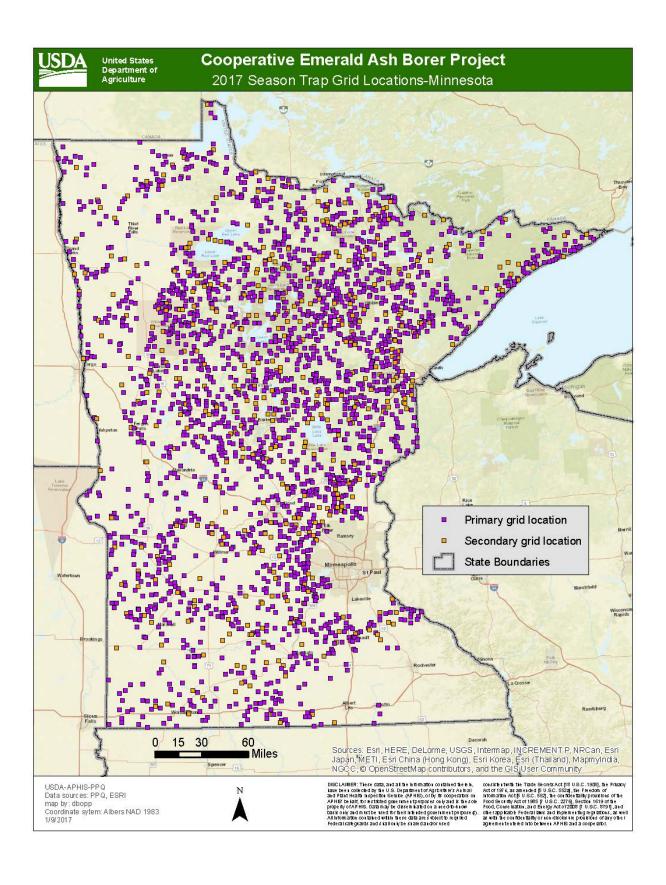


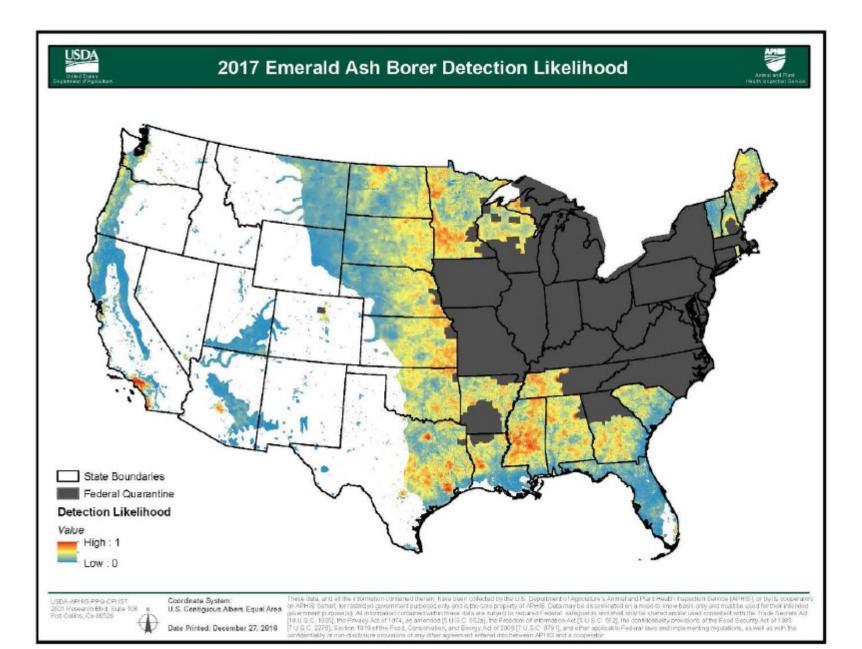


2017 National Survey Grid
