#### Key

This project is to replace #518 a Holder Snow Removal Machine. These machines are necessary to plow sidewalks and pathways. The heavy use of these machines during the winter months in our plowing operation leads to breakdowns and failures as they age. This machine has begun to show significant signs of wear and tear and is essential to our snow removal operation. The current machine will be traded in to offset the deficit of the budgeted amount and actual cost of the new machine. The trade in value is projected to be roughly \$30,000.

This project is to replace #509 and #513 which are Toro 4000 mowers. These mowers are essential to our mowing operation. These mowers run non-stop during the growing season. The mowers are both 10 years old and showing signs of the end of their useful life. The current mowers will be traded in to offsetting some of the cost for a projected amount of \$10,500 each. If ordered now, we hope to have the new machinese delivered prior to the end of the summer of 2023.

This project is to replace the 2011 Elgin Crosswind Regenerative Street Sweeper with the 2023 Elgin Crosswind Street Sweeper. It is ergonomically designed to improve ventilation and visibility for safety. This is the price off of the Minnesota State Bid Contract. The intention is to sell/trade the 2011 Street Sweeper to make up for the difference between actual price of the 2023 Street Sweeper and the budget amount.

 $PLC\ replacement\ upgrades\ update\ the\ master\ controller\ used\ to\ control\ all\ SCADA\ infrastructure.\ This\ upgrade\ will\ bring$ (d) this up to the latest technology. It would be funded from multiple funds includeing the Water Fund, Sewer Fund, and the Storm Fund.

The water tower pressure monitoring provides additional redundancy to monitor the water tower. This will replace a failed sensor. This project would be completed in conjunction with the water tower painting project as it can only be done when the water tower is out of service later this spring 2023.

**Re:** 2023 SCADA Upgrades

There are two SCADA [project upgrades that are planned for 2023 as follows;

- Telemetry Master PLC Replacement \$32,035.00
  - The PLC replacement upgrades updates the master controller used to control all SCADA infrastructure. The upgrade will bring this us to the latest technology.
  - o This would be funded from the following CIP's
    - \$4,368.41 from the water fund of which there is \$100,000 in the CIP.
    - \$17,473.64 from the sewer fund of which there is \$100,000 in the CIP.
    - \$10,192.95 from the storm fund of which there is \$600,000 in the CIP.
- Water Tower Backup Pressure Monitoring \$14,980.00
  - o The water tower pressure monitoring provides additional redundancy to monitor the water tower. This will replace a failed sensor. This project would be completed in conjunction with the water tower painting project as it can only be done when the water tower is out of service later this spring.
  - o This would be funded by the water fund of which there is \$100,000 in the CIP.

These two projects total \$47,015.00. Both projects would be done by AE2s who is the City's consultant used for all SCADA projects. Both projects are needed to keep the City's SCADA system operational which in turn keeps the water system operational.
