Please Share Your Comment, Question or Concern I am not sure how much due diligence the City of Roseville is required to do to vet businesses that do projects in Roseville. That might be a topic for further discussion in the future. However right now you have before you a project from Reuter Walton, and you have information that tells you that there is

reason to be concerned that as part of this project workers will be exploited. Our Police Department has done some really good work to curb sex trafficking in Roseville, and this is just another variation of human trafficking.

There might be a temptation to justify it by saying the complaints are not directly against Reuter Walton, but you know that's the difference between what is on paper and what is actually happening. In this case, it is actually even more serious because our tax dollars will be used to support the project. That means that we would be financially supporting exploitation of workers. When I say 'we' I mean that each of you will be directly supporting this if you vote to approve it, and if you do, you will be forcing each and every person who pays taxes in Roseville to also support it.

Please do not support this project unless you have safeguards in place to guarantee (yes, guarantee) that workers will be protected. That means more than just having something written on paper, it means doing for construction workers what the Police Department has done for sex workers and actively monitoring what is going on. If you are not prepared to do that work, then we should not be involved in this project.

Dear City Council members: We have noted the increasing pressure from a small group of folks on Next-door advocating against the Reuter Walton development in Roseville. This group is making statements that Reuter Walton engaged in wage theft and worker intimidation. We have not yet seen

indisputable evidence cited by them to prove this is so.

While we advocate that the Roseville City Council do due diligence in being sure that there is no credible evidence that Reuter Walton has engaged in such practices, WE ALSO FIRMLY ADVOCATE THAT THE CITY COUNCIL NOT CAVE IN TO INNUENDO AND STRIDENT ATTACKS from a small group of folks who seem determined to block this development.

We call for calm heads to prevail to first determine if these accusations are credible or not. Then a well considered decision can be made by the City Council as whether or not to move forward with the project. It is very concerning to us that this small group is choosing to stridently attack City Council members with accusations of wasting our tax dollars and supporting wage theft if you support this development, rather than take a more measured approach of being sure the situation has been thoroughly examined.
