Item Description: Accept General Donations to the City of Roseville Parks and Recreation

**BACKGROUND**

When staff is notified of a potential donation, they first make a determination of whether to recommend acceptance based on the suitability of the item for the city. An acceptance request is then forwarded to the City Council.

**POLICY OBJECTIVE**

The following is the City of Roseville's policy regarding the acceptance of donations:

- Minnesota Statute requires all donations to be officially accepted by the City Council.
