## City Receives High Marks in 2024 Community Survey

A strong majority of Roseville residents believe our city is headed in the right direction and rate their quality of life as either excellent or good, according to the results of the 2024 Community Survey.

### Some key findings:

**85**% think Roseville is headed in the "right direction"

**85%** rate the general value of city services as either "excellent" or "good"

**86**% say Roseville has a "very strong" or "somewhat strong" sense of community identity

**87**% rate their quality of life as either "excellent" or "good"

**92**% approve of the job the Mayor and Council are doing

**92**% approve of the job city staff are doing

**98**% say they are committed to staying in Roseville

**69%** say they support a proposed half-cent sales tax to construct a parks and public works maintenance facility

**66**% say they support a proposed half-cent sales to construct a new license and passport center

The Morris Leatherman Company surveyed 400 Roseville residents this spring to gauge community perceptions of local government and quality of life. The city last conducted a community survey in 2020.

Residents surveyed also gave high marks to city services including police, fire, streets, water, and sewer.

### Inside Look: Mosaic Cairns in Progress

Nationally acclaimed Mosaic Artist Lori Green has been working on several mosaic cairns made up of thousands of individual tiles. Each cairn features plants and animals that represent the marsh, prairie, and forest that make up Central Park's 52-acre nature preserve, Harriet Alexander Nature Center (HANC).



Cairns are eye-catching landmarks built to mark trails and significant locations.

The City of Roseville commissioned the public artwork with the help of nature center volunteer and donor John and Kris Robertson-Smith, in coordination with the nonprofit Friends of Roseville Parks.

Greene said she was drawn to the project because of its natural family-friendly setting. Greene said she explored HANC with her children when they were young.

### City Manager Presents 2025 Budget

Roseville City Manager Pat Trudgeon has presented the proposed 2025 budget to the City Council.

The approach to the 2025 budget is centered on three main strategies:

- Provide a modern and sustainable infrastructure
- Investment to maintain city programs and workforce
- Strategic use of grant funding

The proposed 2025 budget totals \$73,410,845 and represents a 4.66% increase from 2024 due to higher personnel and supply costs as well as increased capital equipment purchases.

Under this proposal, the total property tax levy would increase by \$1,488,323, or 5.17%, over 2024.

The median-valued Roseville home increased in value from \$349,900 to \$360,500 or an estimated 3.03% value increase over last year. Ramsey County, which oversees property tax assessments and collection, will release additional information on the tax implications later this fall.

The Roseville City Council has approved a timeline establishing dates where they will publicly review and discuss key aspects of next year's budget including the property tax levy and utility rates.

"I wanted to do something that was beautiful and about nature," Mosaic Artist Lori Green says. "It's healing for me. I hope it will be for others. I hope it's also fun for kids and adults too."

Greene's work is displayed all over the country and across the Twin Cities. Two of her mosaics are displayed at the Minneapolis-St. Paul Airport. Green created the Survivors Memorial at Boom Island Park in Minneapolis, which is the nation's first, permanent, public memorial to honor survivors of sexual violence.

Lori owns Mosaic on a Stick in St. Paul, which offers classes and studio space to fellow mosaic artists.



Greene grew up in Minnesota with a plethora of cultural values that guide her work. Greene is multiracial including African American, Native American-Mississippi band of Choctaw, and Caucasian. Her father Dewey Greene was a founding member of the Student Nonviolent Coordinating Committee (SNCC) in the 1960s, which fought for Civil Rights.

Greene said she appreciates that her public art projects reach a broad audience.

"A lot of people feel intimidated by art, I want people to walk by a piece of art and think: 'oh that's cool!' I want people to be interested and to be curious and ask, 'What is that? How is that made? Could I do that?'" she said.

### City adds Accessibility Features, Language Translator to Website

The City of Roseville has added a new accessibility menu to its website that provides a screen reader, a larger type option, and a host of other settings to improve ease of use for all visitors.



The menu can be accessed by clicking on the blue and white circular icon in the top right corner of the screen. The city has contracted with UserWay to provide the menu, which complies with the Americans with Disabilities Act. The service is free to all users.

"We want to ensure all residents and visitors have quick and convenient access to our city website including information about our programs, services, council and commission actions, and community events," said Assistant City Manager Rebecca Olson.

The menu, also called a widget, includes accessibility profiles for individuals with the following conditions:

- blind
- motor impaired
- color blind
- dyslexic
- low vision
- ADHD
- seizures and epilepsy
- cognitive and learning disabilities



The UserWay menu also allows users to adjust type size, spacing, contrast, saturation, and a host of other settings. Users can hide all images, pause animations and have webpages read to them. The screen reader translates the site into 50 languages and dialects.

UserWay does not collect any personally identifiable information or behavioral data from websites or visitors. The City of Roseville is spending \$1,800 annually to provide the accessibility menu.

In addition to the increased access offered by UserWay, the website also utilizes Google Translate. The widget is located in the lower right corner and translates the website into more than 200 languages. The city added that feature a few years ago to better serve our diverse community.

A group of OVAL boosters want to add more sparkle to Roseville's iconic outdoor ice rink!

The Friends of the OVAL Foundation is raising \$60,000 to illuminate the OVAL for the next two years. The goal is to add hundreds of strands of seasonal lights to the evergreen trees surrounding the largest refrigerated outdoor skating rink in North America.

The OVAL was brilliantly illuminated from 2013 to 2018 with help from the Friends of the OVAL and the Roseville Visitors Association. Annual fundraising became time intensive, and the last of the holiday lights burnt out in 2020 and were not replaced.

### **Building Our Shared Future Together**

The City of Roseville is committed to providing essential public services for all 35,000+ residents and the tens of thousands of daily visitors who work, shop, and dine in our city.

The city has put forward a \$76.9 million investment plan, called "Invest in Roseville," to replace the aging Public Works and Parks Maintenance Facility and License and Passport Center with new buildings that will be better equipped to provide the essential services our residents and businesses expect and deserve.

This November, Roseville voters will consider two separate ballot questions to finance the 1) Maintenance Operations Center for \$64.2 million and 2) License and Passport Center for \$12.7 million.

Residents will vote on November 5 on whether to support both projects with a half-cent local sales tax. If approved by voters, the sales tax would be in place for 20 years, or until the approved projects are paid for — whichever happens first. The proposed sales tax will pay for both projects.



### **Frequently Asked Questions**

### Why a local sales tax?

The City Council determined that a local sales tax was the best local funding option because both residents and nonresidents would share the cost of this investment.

According to the University of Minnesota, 64 percent (\$49 million) of the sales tax would be paid by nonresidents who regularly use the city's parks and public amenities.

The cost of the half-percent sales tax for each Roseville resident is estimated to be \$4.62 per month, or \$55.48 a year, according to the study by the University of Minnesota. If a property tax increase was used to cover the costs, the owner of a \$350,000 home in Roseville would pay about \$30 a month, or \$360 a year.

The State Legislature authorized the city to seek a half-percent sales tax to finance the construction

of the projects. Same as the state sales tax, a wide range of essential goods would be exempt from the city sales tax, including groceries, clothing, and prescriptions.

If approved, the sales tax would be in place for 20

years, or until the projects are paid for — whichever happens first.

### Why is the city proposing to build a new Maintenance Operations Center?

The building serves as the operational hub for a fleet of more than 300 city vehicles, water and sewer systems, road work, snow removal, and critical maintenance of the city's 32 parks.

Portions of the existing Maintenance Facility date back to 1957 and are no longer equipped for the variety of maintenance operations and essential city services it supports. Many of the facility's central systems are past their useful life, including the fuel system, security system, roof, and drainage systems.

Due to cramped quarters, the city has been forced to lease space offsite for storing large equipment and vehicles including snowplows that require regular maintenance. This slows response times to the 12,000 service calls received annually and adding time to complete ongoing project work.

If the sales tax is approved, almost two-thirds of the costs will be paid by visitors when they make purchases in Roseville.

### **How will a new Maintenance Operations Center help?**

The new Maintenance Operations Center will be a versatile, multipurpose facility roughly three times the size of the current building. It will be a modern and centralized, one-stop-shop for service, storage, and maintenance needs.

### Why is the city proposing to build a new License and Passport Center?

The License and Passport Center has become one of the busiest in the state processing more than 185,000 transactions per year for driver's licenses, vehicle tabs, hunting and fishing licenses, and passports.

With nearly double the space, the new center will create an improved customer experience. The License and Passport Center is a significant revenue generator for the city.

Approximately \$400,000 annually from the License and Passport Center is used to offset the costs of other city operations for

### Look for these Questions on your Ballot

## Question 1: Sales Tax for Public Works and Parks Operations Facility

Shall the City of Roseville impose a one-half of one percent (0.5%) sales and use tax for up to 20 years to collect \$64,200,000, plus the costs of interest and of issuing the bonds, to build a public works and parks operations facility? By voting "yes" on this question, you are voting to increase the sales tax in Roseville.

If one or both questions are approved by the voters, the City is only authorized to impose a single one-half of one percent (0.5%) sales and use tax for the lesser of 20 years or until enough sales tax revenue has been raised to pay for the costs of one or both of the proposed projects.

### Question 2: Sales Tax for License and Passport Center

Shall the City of Roseville impose a one-half of one percent (0.5%) sales and use tax for up to 20 years to collect \$12,700,000, plus the costs of interest and of issuing the bonds, to build a license and passport center? By voting "yes" on this question, you are voting to increase the sales tax in Roseville.

If one or both questions are approved by the voters, the City is only authorized to impose a single one-half of one percent (0.5%) sales and use tax for the lesser of 20 years or until enough sales tax revenue has been raised to pay for the costs of one or both of the proposed projects.



### How do we stack up to other cities?

Many communities in the Twin Cities have passed local sales taxes including St. Paul, Minneapolis, Edina, Bloomington, Golden Valley, Oakdale, and Maple Grove.





Police officers play a vital role in our community. Hiring the best individuals to fill officer positions is a top priority.

That's why Roseville Police Department leaders have invested in a variety of recruitment programs to attract, train, and retain the best people in a competitive job market.

"In law enforcement, we've seen a dramatic decline in the number of officer applicants over the past five years. We knew we had to grow our own," said Assistant Police Chief Joe Adams.



Recruitment efforts include working with high school students, college students, groups traditionally underrepresented in law enforcement, professionals looking to make a career change, and successful police officers from other departments who want to work in Roseville.

Here's some of the ways Roseville Police are tapping into talent.

### **Roseville Police Explorers**

The program is designed for high school and college students, ages 14 to 21, interested in a career in public safety. Explorers meet regularly and learn about policing from Roseville officers who serve as advisors.



They get a first-hand glimpse into the challenging and rewarding field of police work through ridealongs and department tours.

Roseville Police Explorers compete with other Explorer programs across the state in events that test their new knowledge and skills.

### **Police Interns**

Roseville Police was one of the first agencies to launch a paid part-time internship program for college students majoring in criminal justice. It replaced an unpaid program.

"We decided to pay our interns, because we understand that many college students simply can't afford to work for free," Adams said. "It's working. We had 100 applicants for our most recent internship."

Interns are hired three times a year and are assigned to different units in the police department including investigations and the Community Action Team. They assist officers and learn more about the rigors of the profession.

"Our paid internship program has really become the equivalent to our farm team. It's been very successful. Our interns do apply for next-step positions in our department including Community Service Officer and Cadet," Adams said.

### **Community Service Officer/Cadet**

Community Service Officers and Cadets assist police officers on a daily basis as well as work independently. They respond to animal control calls; conduct parking enforcement; transport suspects to jail; and assist police officers, EMS, and firefighters with traffic, crowd and scene control at major incidents.

CSOs are students enrolled in a two-year or fouryear law enforcement or criminal justice program. CSOs work approximately 20 hours a week. Cadets are either college students or recent graduates and are full-time positions.

Benefits include flexible scheduling to accommodate coursework, tuition reimbursement, mentoring from a department police officer, and specialized training opportunities.

Both CSOs and cadets who finish their degrees often apply and are hired into Roseville police officer positions.



### **Pathways to Policing**

This tuition-reimbursement program funded by a state grant is designed to recruit groups underrepresented in law enforcement including women and people of color. Access to this funding has been and continues to be a deciding factor for candidates when selecting Roseville as the community they serve.

### Intensive Comprehensive Peace Officer Education and Training

This new program funded by a state grant helps professionals with college degrees already in the work world transition to a career in law enforcement. Participants enroll in an 11-month accelerated law enforcement program at Hennepin County Technical College. The program covers tuition and provides a salary while they're studying.

### **Lateral Hires**

Before 2020, all police officers hired in Roseville had to start at the bottom of the pay scale regardless of past experience. That prevented officers from other states and other local departments from applying to work in Roseville.

Now, officers transferring from other departments receive credit for previous experience and start in Roseville with a comparable salary. Hiring bonuses ranging from \$5,000 to \$10,000 also sweeten the deal.

This program has helped Roseville recruit and hire mid-level officers who often have roots in the community.

"We find many officers who left the state after college to launch their careers are now looking to come back home to Minnesota. We've hired officers from California, Washington State, Michigan, Montana, and other Minnesota agencies," Adams said.

### **Smoke Alarms: Make Them Work For You**

A working smoke alarm can make the difference between surviving a house fire and perishing in one.

Smoke alarms reduce the risk of dying in a home fire by 54 percent, according to the National Fire Protection Association.



Roseville Fire Department urges residents to make sure their smoke alarms are working as part of National Fire Prevention Week, which is October 6-12. This year's theme is, "Smoke alarms: Make them work for you!"

"Smoke alarms save lives. That's why it's so important to keep your home's smoke detectors in good working order," said Roseville Assistant Fire Chief Neil Sjostrom. Roughly three out of five fire deaths happen in homes with either no smoke alarms or no working smoke alarms. Home fires killed more than 2,700 people in the United States in 2022, according to the National Fire Protection Association and fire departments in the United States responded to 360,000 home fires.

Roseville Fire Department offers these key smoke alarm safety tips and guidelines:

- Install smoke alarms in every bedroom, outside each separate sleeping area (like a hallway), and on each level (including the basement) of the home.
- Make sure smoke alarms meet the needs of all family members, including those with sensory or physical disabilities.
- Test smoke alarms at least once a month by pushing the test button.
- Replace all smoke alarms when they are 10 years old.

## Finance Commissioner Brings Valuable Experience, Skill Set to the City

Roseville resident **Bruce Bester** served as a nonprofit chief financial officer for decades managing a \$35 million budget for a charity that helped adults with disabilities. In that capacity, he was named CFO of the Year by the Minneapolis/St. Paul Business Journal.

He retired from that role in 2015 and focused on his own financial consulting firm helping clients invest their nest eggs.



Bester is now using his expertise to keep an eye on the City of Roseville's money matters as chair of the Finance Commission. He has served on the commission for four years.

"There is so much alignment with what I have done in the past and what the city's accounting and financial reporting is all about. It just seemed like a perfect fit," Bester said.

The seven-person volunteer commission advises the City Council and professional city staff on both short-term and long-term financial policy matters, including budgets, capital replacement policies, and cash reserves. The City of Roseville has about a \$70 million annual operating budget, which includes police, fire, water service, roads, and parks. The commissioners also advise on the \$200 million capital budget, which is used to repair and replace equipment and infrastructure.

"Our first mission is to make sure the city is healthy financially. Our second mission is to watch out for the taxpayers including business and homeowners," Bester said. "I want to make sure they are being considered in the process."

The commission, which meets monthly, helps provide transparency for the public.

In addition to meetings, Bester said he spends countless hours at home reviewing documents.

"I find this work really fulfilling. It allows me to continue to use the skills, training, and experience I have for what is a good purpose," Bester said. "There are not a ton of people capable or willing to do this work."

Roseville Finance Director Michelle Pietrick praised Bester's and the entire commission's dedication to the city.

"I am grateful for Bruce's time and commitment," Pietrick said. "I know he cares deeply about our community and devotes many hours to understanding all the intricacies of our budgeting process."

And while the bottom line is important, the finance commission must ensure that spending and budget also align with the community's values, Bester said. For example, the city decided to spend more upfront on an electric fire engine instead of a diesel one, because the electric model will last longer, reduces emissions, and aligns with the city's sustainability goals.



Bester has lived in Roseville on Lake Owasso for 23 years. When he's not reviewing the city's finances, Bester is a slalom water skier, who regularly skis Lake Owasso with friends. He spends winters in Florida training with a professional slalom water

In Minnesota, Bester also volunteers with the nonprofit Courage Center, helping people with disabilities experiencing water skiing and sports.

Roseville Resident Alana Howey sees climate change as one of the most urgent global problems of our time. She believes combating it is her legacy.

"In this age of climate change, I want my children, my neighbors, and my family to know that I did what I could," Alana said.

Alana has leaned into local volunteer work, education, and advocacy to combat climate change and promote sustainable practices.

She rolls up her sleeves and volunteers for the City of Roseville planting trees and removing invasive plants from local parks. She's even slipped on some gloves and "guarded the garbage" helping revelers sort compostable and recyclable items into the appropriate bins at zero-waste community events including Juneteenth and Tapped & Uncorked.

Alana said members of the public are often pleased to see the city promoting recycling and composting but can get a bit overwhelmed with thinking about that as an issue and a choice.

"We are doing a lot of education," said Alana, who works as a physical therapist. "The challenge is to make recycling and composting easier and easier for people. We want businesses to shift their practices and for people to make different choices."

Roseville Volunteer Manager Rachel Boggs praised Alana's contributions and said the city is actively recruiting more volunteers who are interested in diving into sustainability projects around the city.

"We are actively trying to grow our sustainability volunteer group and we encourage any interested community member to reach out," Boggs said. "There are many ways to help us engage others in our community as we promote our sustainability efforts."

Alana also advocates for changes in local policies and practices at Roseville City Hall as a founding member of Resilient Roseville, a coalition of residents contributing to and promoting climate action projects and environmental resilience.



"I felt there was a need to nudge the city to move along those lines," Alana said.

Alana and her fellow group members educate the public about ways to be more sustainable in their everyday activities including cooking, commuting, shopping, and home and lawn maintenance.

Alana had her husband have incorporated sustainability into their daily lives. The couple was one of the first in the city to install solar panels on the roof of their home and backyard pergola nearly two decades ago. Their front lawn is a native landscape flush with wildflowers and humming with butterflies, bees, and birds. Their backyard includes apple trees, a large vegetable garden, raspberry patch, and more vibrant blooms. The couple also prioritizes sustainable technology and practices in their property rental business.

"You have to be active and you have to hope. You have to be involved. Otherwise, you just go to despair and that is no way to live," she said.

Thank you to the thousands of residents who participated in Lead Free Roseville.

The Minnesota Department of Health required all public water systems to document what material the water service to the homes and businesses are made of. The goal was to identify if any service lines are lead.

So far, 86% of the 10,330 households and businesses either phoned or emailed in information about the composition of their waterlines.

The City of Roseville's water system was started in the mid 1960's, so only 25 homes were found to have a portion of their service pipe comprised of lead.

There's still time to submit your information before the fall deadline. To complete this task, the City is requesting residents submit information about their water service or arrange an inspection by the City.
