### **Roseville Welcomes "Sunset Park"**

The City of Roseville's newest greenspace will be called Sunset Park, nodding to its location on the western edge of the city.

The City Council approved the name at a joint meeting with the Parks and Recreation Commission on Sept. 16.

The city is developing the new neighborhood park as part of the city's ongoing commitment to providing public green space within walking distance of every residence and the city's Parks and Recreation System Master Plan.

Parks leaders designed the .8-acre park at 2381 County Road B after holding four neighborhood planning meetings in 2023. Sunset Park will include a playground, nature loop trail, basketball shooting area, and picnic space.



In 2022, Roseville acquired the property via a combination of the city's park dedication requirement for new development and cash purchase.

Construction has been ongoing at the new park throughout the summer. This fall, neighbors and other community volunteers helped staff and contractors install the new playground on the site.

"It's been a lot of fun working with the neighborhood to design and develop this new park. Due to the unseasonably temperate and dry fall that we've had, work at Sunset Park is substantially complete nearly a month ahead of schedule. We will still plan on some kind of official acknowledgement or ribbon cutting in the spring," said Roseville Parks and Recreation Director Matthew Johnson.

This will be Roseville's 33rd park. Parks Superintendent Jim Taylor said the city has added three new parks in recent years.

### **2025 Preliminary City Budget and Tax Levy Approved**

The Roseville City Council approved its preliminary budget in September.

The Council will take public comments at the Truthin-Taxation Hearing on Nov. 25 and will approve the final 2025 budget in December.

The proposed 2025 budget is \$73,509,845 and represents a 5.4% levy increase from 2024 due to higher personnel and supply costs, as well as increased capital equipment purchases.

State statute requires cities to adopt a preliminary budget and tax levy by Sept. 30 for the upcoming fiscal year. Once the preliminary levy is adopted, it can be lowered but not increased.

For a median-valued single-family home valued at \$360,500, the 5.4% levy increase will result in the homeowner paying \$9.72 more per month for city services.

The 2025 budget is centered on three key strategies:

- Provide a modern and sustainable infrastructure
- Investment to maintain city programs and workforce
- Strategic use of grant funding

### **City to no Longer Collect Water Meter Deposits**

On March 18, 2024, the City Council approved a resolution to refund water deposits to residents and commercial customers. As a result, customers with a deposit on their account will see a credit on their upcoming utility bills from the City of Roseville. The refunds will vary based on the date when each customer initially established water service. Going forward, the city will no longer collect or retain water meter deposits.

### Thin Ice at Central Park

The City of Roseville uses an underwater aeration system to support the fish population throughout the winter months. The system increases the amount of dissolved oxygen in the water, which supports the lake's sunfish, bluegill, and bass population, said Roseville Environmental Manager Ryan Johnson. It also creates thin spots in the ice.

Johnson said residents should avoid walking on the ice at Bennett Lake and any body of water in the city due to the potential of thin ice spots.

#### **OLD DUTCH THEN**

Founder Carl J. Marx started frying up potato chips in his Grand Avenue home in St. Paul in 1934.

Marx called his chips Old Dutch because he associated that culture with cleanliness and quality, according to news reports. That brand, with its distinctive red and yellow windmill logo, had staying power. In decades past, women dressed as Dutch maidens helped to sell the chips in grocery store aisles across the Midwest.

Old Dutch operations expanded and moved to Minneapolis in the 1940s. Old Dutch settled in its current location on Terminal Road on Roseville's west end in the 1960s after a fire destroyed its Minneapolis facility. The chip company was part of the suburb's mid-century building boom. Old Dutch joined a growing group of innovative businesses moving to Roseville including Rosedale Center, one of the first enclosed shopping malls, and the first Target store in the nation.

### **OLD DUTCH NOW**

Today, Old Dutch Foods, Inc. employs more than 600 people, mostly in Minnesota. Old Dutch remains locally owned and operated by the Aanenson family and is a part of Roseville's diverse industry base. Manufacturing makes up 9% of the nearly 36,000 jobs in Roseville.

The company's Roseville facility is at full capacity, but they're primed for growth. They own an adjacent property for future expansion.

Old Dutch is best known for its distinctive box packaging containing two bags of potato chips, referred to as twin packs. Old Dutch and its other brands, Barrel O' Fun and Humpty Dumpty, are sold in 19 states and nationwide in Canada. Products include potato chips in a variety of flavors, tortilla chips, cheese puffs, pretzels, popcorn, and dips.



A group of OVAL boosters wants to make Roseville's iconic outdoor ice rink shine!

The OVAL was named the winner in the 2023 USA TODAY Readers' Choice travel award contest for Best Ice Skating Rink! The OVAL finished first, beating out nine other nominees that were selected by an expert panel. The public was then asked to vote for the rink that provided a "superior ice skating experience."

This November, Roseville voters will consider two separate ballot questions to finance the

- 1) Public Works and Parks Operations Facility for \$64.2 million and
- 2) License and Passport Center for \$12.7 million.

Residents will vote on November 5 on whether to support both projects with a half-cent local sales tax. If approved by voters, the sales tax would be in place for 20 years, or until the approved projects are paid for — whichever happens first. The local sales tax will be 0.5% if one or both questions pass.

### **PROJECT FOCUSED QUESTIONS**

### What is the "Invest In Roseville" plan?

The proposed plan is a \$76.9 million community investment to replace the aging Public Works and Parks Operations Facility and License and Passport Center with new buildings that will improve public services for Roseville residents.

The new Operations Facility will be a flexible, multipurpose facility that is roughly three times the size of the current building, allowing staff to more efficiently manage and maintain the city's fleet of over 300 vehicles, water distribution systems, roadwork, snow removal, and 32 parks. Unlike the current building, the new facility will be a centralized, one-stop-shop with adequate space for storage, service, and maintenance needs.

As one of the busiest registrars in the state, the new License and Passport Center will support more efficient license and passport processing for thousands of city residents and other Minnesotans. With nearly two times the amount of space at the current facility, the new center will create an improved customer experience.

# Local Sales Tax in the Twin Cities Metro Area In Effect Proposed STRAUL ST

### How was the plan developed?

Recognizing the lack of space and aging infrastructure at both the Public Works and Parks Operations Facility and License and Passport Center, the City of Roseville conducted a space needs assessment in 2017 that found major deficiencies in both buildings. The city then hired the BKV Group to help develop a master plan for optimizing public services for Roseville residents in 2021. This entailed another space needs assessment and a series of engagement efforts with project and community stakeholders to identify current and future needs. This assessment found that:

- The Public Works and Parks Operations Facility needs roughly three times the current space to manage operations, repairs, and calls for snow removal or maintenance.
- The License and Passport Center needs roughly two times the current space to meet federal standards for managing operations.

### **SALES TAX FOCUSED QUESTIONS**

### Why use a local sales tax to fund these projects?

The City Council chose a local sales tax because it would spread the cost of the projects among residents and nonresidents who make purchases in the city and benefit from city services. If approved by voters, 64% of the sales tax would be paid by nonresidents according to an independent analysis by the University of Minnesota Extension Center for Community Vitality.

For each Roseville resident, the cost of the 0.5% sales tax is estimated to be \$4.62 per month, or \$55.48 a year, according to the University of Minnesota research. If the projects were funded through a property tax, a median-value home would increase by approximately \$30 per month, or \$360 per year.

### Are there exemptions to the sales tax?

The local option sales tax has the same exemptions for purchases as the state sales tax. Sales tax wouldn't be collected on groceries, clothing, prescription and over-the-counter drugs, feminine hygiene products, and baby products. Sales of motor vehicles and boats are also exempt.





### **Tips for Navigating Snow Plow Season**

Winter is on the horizon.

That means Roseville plow drivers will soon be out on the streets and the City of Roseville's winter parking restrictions go into effect. The city typically deploys up to a 16-person team to plow streets after each snow event.

No parking is allowed on most city streets when there has been two inches or more of snowfall until the street has been plowed curb to curb.

This winter, the city will allow limited street parking during snowfall in six designated areas as part of the Winter Parking Pilot Project.

The pilot project is designed to allow for muchneeded street parking in areas near multifamily housing complexes but still ensures that all city streets are properly plowed.

City crews have installed new signs in the designated areas. The new signs allow parking on one side of the street (blue side) when there is a snow event. Once the street is plowed, residents must move their vehicles to the other side of the street (green side) so the remainder of the street can be plowed.

"We recognize the financial hardship and frustration the tickets can cause to individuals and families, so we're using this project to provide additional parking options and reduce those penalties on individuals and families."

- Place garbage and recycling bins on your driveway apron on trash day instead of on the curb. This will allow plow drivers to more thoroughly clear the street and will help prevent carts from being toppled by plowing
- Don't park your car on the street after a 2" snowfall until the street has been plowed curb to curb. When 2" of snow has accumulated, on-street parking is banned and vehicles could be ticketed and/or towed.
- Avoid plowing snow back into the road when you are clearing your own driveway and walkways.
- Please be patient with pedestrian pathway plowing. City public works crews plow roadways first and parks crews follow up with pedestrian paths after a snow event.

The City of Roseville is offering up to \$300 off your water bill when you replace your toilet, washing machine, dishwasher; or upgrade your irrigation system with new, more efficient models.

Roseville is offering the rebate program in partnership with the Metropolitan Council and the Clean Water Land & Legacy Amendment. The city still has \$19,000 to distribute.

Residents who purchase qualifying WaterSense® toilets; ENERGY STAR-Certified clothes washers or ENERGY STAR-Certified dishwashers are eligible for a 50% rebate up to \$300.

Residents who upgrade to WaterSense® labelled irrigation equipment can receive a 75% rebate up to \$300.

It's as simple as saving your itemized receipt, filling out a one-page application and snapping a photo of your new appliance.

Existing homes are eligible for this rebate. New-construction homes do not qualify.



# A Commissioner's Commitment to Roseville Parks and Recreation

Lindsay Matts-Benson fills an important role in the City of Roseville as the chair of the Roseville Parks and Recreation Commission.

She and the other volunteer commissioners meet each month in the City Council Chambers to advise on parks projects and programs.

But Lindsay said it's her experiences in the community as a parent, youth coach, and parks and program user that really inform and define her commission work.



"I see myself as an ambassador for the city parks and recreation system. I am out there talking to people in my everyday life about the parks and the rec programs." said Lindsay, whose two children have been in recreation activities including Kicker and Slugger, soccer, and dance.

"I get to be both a participant, see things, hear feedback from other parents, and be able to bring those insights - both complementary and constructive - back to the parks and rec department."

The Roseville Parks and Recreation Commission consists of 10 members who serve three-year terms.

Their responsibilities are to:

- Provide citizen input about city's parks, recreational facilities, programs, and other services provided by the parks and recreation department.
- Learn about and provide feedback on projects, plans, and programs that impact the parks and recreation system.
- Engage with the community and convey feedback to staff and the City Council.

The commission covers a lot of ground. The City of Roseville has 33 parks spanning nearly 680 acres, rentable buildings and picnic shelters, an arboretum, skating center, nature center, Cedarholm Golf Course, and dozens of youth and adult programs.

"Understanding the needs and wants of the community is crucial for us to provide a high level of service to our residents. The feedback we receive from our Parks and Recreation Commissioners, both at monthly meetings and informally as individuals, is integral to that process," said Parks and Recreation Director Matt Johnson.

"Over the years we've been blessed with an amazing group of passionate, engaged, and energetic commissioners who have worked with us to ensure that Roseville gets the best parks, programs and services possible."

In recent years, Lindsay said the parks commission provided feedback on updates to Rosefest, the city's annual celebration. She said the refreshed 2024 Rosefest delivered.

"It was wonderful. I believe my kids said it was the best Rosefest ever," said Lindsay, whose daughter is 9 and son is 6. "It's a low-cost fun event. There was such good energy at Party in the Park."



The commission also advised the City Council and staff on the renaming of Keya Park to honor local indigenous culture. Keya means turtle in the Dakota language.

Lindsay, a librarian at the University of Minnesota, said the commission supported adding interpretive signs and leaning into the turtle theme with a new, imaginative playground that mimics a larger-than-life wetland.

"Staff knows I will give them an honest answer with how things are going, and I can help them find additional community feedback," she said.

# Recycling Plant in Roseville keeps tons of waste out of landfills

Recycling is a way of life in Minnesota. The state ranks in the top three in the nation for cardboard, boxboard, and paper recycling.

The International Paper Twin Cities Recycling Plant in Roseville helps make Minnesota's recordpace recycling possible.

International Paper staff receive, sort, and bale tons of used boxboard, paper, and other materials from businesses.

"The facility's main focus is to create 2,000-pound bales of brown recycled fiber, handling approximately 7,000 tons a month," said General Manager John Saladis.



Most of those bales are shipped via rail to the company's Cedar Rapids, Iowa, facility, where they are recycled back into shipping material. The Iowa plant is one of the most efficient in the country, recycling more than one million tons of containerboard a year that otherwise would go into a landfill.

The Roseville plant is a 200,000 square foot facility with roughly 20 employees and four commercial truck drivers operating two shifts daily.

"IP is an end-to-end closed loop sustainability partner." he said. "Being part of the circular nature of our activities to intercept paper before it heads to a landfill is gratifying. For us, recycling is a culture, not a commodity."



### **Community partner**

The Roseville facility offers numerous options for customers to best handle their recycling streams. Whether through 96-gallon rolling bins with lids and rolling carts or compactors and balers, Saladis wants to ensure recycling is routine.

"Businesses should focus their time, energy and money on other priorities," he said. "Recycling materials these businesses need every day makes sense, but so does an attitude of businesses and employees doing what is right for the community. We want to be part of that narrative."
