ORDINANCE NO. 1685

AN ORDINANCE AMENDING CHAPTER 314, FEE SCHEDULE

WHEREAS, the City of Roseville reviews and updates penalties and fees annually to ensure consistency and transparency, and to appropriately recover costs; and

WHEREAS, as part of the City's recodification process, it is the desire of the City Council to reorganize the schedule for better ease of reference and transparency; and

WHEREAS, at the time of adoption of the recodification, the fee schedule will be moved into an appendix to the city code and all references in the city code to fees or penalties will be updated accordingly; and

WHEREAS, the format of the fee and penalty schedule is being updated in advance of recodification of the entire city code in 2025, and, at the time of such recodification, will be removed from the main code and adopted as an appendix to the city code; now, therefore, be it

RESOLVED, that the City Council of the City of Roseville does ordain:

SECTION 1: Title 3, Chapter 314 of the Roseville City Code is amended as follows:

314.01: PURPOSE AND FINDINGS

The City of Roseville annually adopts a Fee Schedule which establishes the fees and charges for service for the City's regulatory functions. The presence of a fee schedule allows regulatory-type fees to be easily identified in one document, as opposed to being scattered throughout City Code. In addition, a fee schedule adopted on an annual basis provides the City Council the opportunity to review fees for services in a comprehensive manner.

314.02: OTHER FEE REFERENCES

By enacting this ordinance, all fee amounts previously established and contained

herein are hereby amended as submitted.

314.03: AUTHORITY

The authority to enact the fees identified herein is established by City Code.

314.04: PENALTY

Failure to pay the fees identified herein is subject to penalties and interest as established by City Code.

314.05: FEE SCHEDULE

The ~~2013~~ 2025 Fee Schedule is as shown in 314.051 – 314.054. (Ord. 1431, 11-19-2012), (Ord. 1433, 01-28-2013) (Ord. 1458, 11-18-2013) (Ord. 1484, 11/24/2015)

SECTION 2: The Tables found within Title 3, Chapter 314 of the Roseville City Code are amended as follows:

The Table at Section 314.051 “General Business Licenses and Fees” is repealed in its entirety and replaced with the attached “General Business licenses and Fees”.

The Table at Section 314.052 “Administrative Fines” is repealed in its entirety and replaced with the attached “Administrative Penalties”.

The Table at Section 314.053 “Building Permit and Plan Review Fees” is repealed in its entirety and replaced with the attached “Permit and Plan/Project Review Fees”.

The Table at Section 315.054 “Electrical Permits” is repealed in its entirety and replaced with the attached “Electrical Permits”.

Section 315.055, attached as “Community Development Miscellaneous Fees” is hereby created.

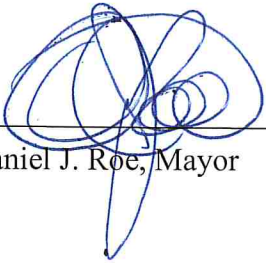
SECTION 2. Effective Date. This ordinance shall be effective upon adoption and publication.
