I apologize that I will not be in attendance and able to contribute to our continued discussions regarding Council priorities at the February 7, 2011 meeting. My presence is required in Montana at a family funeral.

I have provided below my thoughts on the issues that should guide the Council's work – over the next two years. Where appropriate, I have also referenced my support for specific suggestions made by the Department heads last week, as highlighted in pink. I have taken as a given that they will all be guided to accomplish the priorities they identified as "must dos", and so have not included any of those items in my rankings. Instead, I have focused my attention on identifying which of their "ought to do" priorities should in fact be reprioritized to become "must dos" as well.

Must Do's

- Strengthen Financial Stability of City Budget System
 - o Adopt a Two –Year/Biennial Budget
 - Build Regional Partnerships to Reduce Costs and Improve/Maintain Public Services
 - [CD] Pursue partnerships with surrounding municipalities for shared service opportunities of the Department's services.
 - [CD] Allow for field data entry and external access to the network by inspection staff.
 - [PD] Enter into a financial partnership with Rosedale and/or other merchants to fund an additional patrol officer dedicated to those retail areas
 - [FD] Evaluate current and future opportunities for service improvements and cost recovery
 - [FD] Continue to pursue opportunities for sharing of services with surrounding fire departments
 - [FIN] Reallocate resources based on measured performance results and citizen satisfaction.
 - [Admin] Identify performance measurements that reflect the needs and wants of the community

• Increase and Improve Public Transit Options in Roseville

- o Resurrect NorthEast Corridor Planning in Coordination with Metropolitan Council
- Improve Walkability of Neighborhoods By Continuous Additions of Trails and Sidewalks

• Improve Quality of Housing

Subject: Council Work Plan Suggestions/Items of Interest

Dear Fellow Councilmembers and Staff:

Thank you again for your participation in a good discussion, part 1, this past Monday.

Per our homework assignment, I offer my suggestions for 2011/12 work plan items, in no particular order:

1. Reinvigorate the Imagine Roseville 2025 implementation process.

Involve a group of committed citizens in developing ideas for implementation, including: Ways to check our progress as a city in implementing the strategies and achieving the goals; when and how to update goals and strategies; how to communicate IR2025 with our citizens, businesses, faith groups, and public sector partners; what type of presence for IR2025 on the web; etc.

2. Develop and implement a Capital/Infrastructure replacement & maintenance financing plan

What items are not currently on the CIP? What items (or types of items) will we plan to bond for? What items will we save ahead for? What items are so frequent in recurrence that we must essentially pay cash for every year (i.e. police squads)? What items will we simply not do? (Remove them from CIP!) What about funding for ongoing maintenance and repairs, between replacements? How does the plan work over a long time-frame (i.e. ~60-years)? (Reference Shoreview's "Comprehensive Infrastructure Replacement Plan"

Build on lessons from Parks Master Plan implementation process.

Be sure to include parks implementation items and currently not-included IT and communications items (new council chamber cameras, etc.) on CIP lists.

3. Continue to explore shared services.

Contract w/ neighboring cities for fire and/or emergency medical coverage? Explore pooled HR services and/or health insurance purchasing groups? Provide maintenance/management of school district fields, and/or parks in neighboring cities? Etc.

4. Develop better connections between city government, school districts, and public and private providers of services to those in need in our community.

Regular, routine meetings between key players – school reps, police & fire reps, code enf and HRA reps, parks & rec reps, county reps, local faith group reps (churches, Love INC, Habitat groups, etc.), NWYFS, Keystone, senior programs, etc. Work to establish strong connections between those who encounter folks in need (schools and city staff) to those who provide services for folks in need (volunteer groups, county agencies, etc.)

5. Budget process fine-tuning.

Make sure our program listing is adequate for the purpose and understood by all participants in the process; make sure our documentation matches the process; make sure our fund structure matches our budgeting process and decision-making (i.e. – more funds, different types of funds, fewer funds, etc.) Ensure public and staff input/dialog with council throughout process. Update policies as needed to match changes to the process.

6. Zoning code "tweaking"

Review the specific topic of increasing set-backs in all districts from adjacent MDR and LDR properties. (Base such set-backs on building height, for instance?)

7. Support Human Rights Commission efforts on civic engagement and neighborhoods.
